

September 2010 D2 Meeting Minutes

Call to order:

Rodney Robinson calls meeting to order at 19:30

Approval of Minutes:

August mtg. minutes were not distributed/no approval. (Rodney took Aug. minutes in Jill's absence)

Treasurer Report:

Mike Rainville : absent/ no report.

Registrar Report:

Melinda Rainville: Transfer and add requests are high. There has been uncertainty about the new playing league rules, especially from the Redwood League.

Referee Report:

Tom Dunlap: There were 31 send offs for Bay/Coast Leagues opening weekend and the new send off process was used. We were on budget for the new send off system (\$1000). No one is currently handling the State League send offs. There were 4 State send offs on opening weekend. Some state teams are requesting state refs for state league games. Ken G. is booking referees for State League games. Referee requests for weekend games at MHSC are due by the previous Wed. in order to schedule the refs.

Disciplinary:

Tino Silva: There were three incidents reported. 1) U18 B- bench clearing brawl between WV and Gilroy has resulted in the WV team being disbanded. No hearing.

2) U11G- MTH v. San Benito- waiting on ref report regarding coach swearing incident.

3) U17 B- Juventus v. SSJ (State Premier game)- a red card and six game suspension was issued due to violent conduct involving a GK. Still pending: Juventus parents and coaches accosted the referees after the game, which may be considered referee assault resulting in a 1 yr. coach suspension.

Field Report:

Bob Joyce: San Benito offer is \$1.85 million, and a draft of the contract on the

new property is being developed. We will vote at the October mtg. to accept the selling and purchase contracts and contingencies.

CCSL:

George Tharakan: There was no CCSL committee mtg. since the August D2 mtg. The rules have been updated to correct the U9-U12 game duration times. There are 923 teams participating in the Bay and Coast Leagues.

CCSL Issues needing attention:

- Multiple matchcards
- Centralizing game sites and referees
- Centralizing site administration of corner flags
- Software issues- multiple software packages being used, allow state league games through common system
- Obligation to keep Cal N. updated
- Need for tactical rules regarding seeding, relegation and promotion
- Scheduling: (some teams had 5 double-header weekends with 6 weekends off)
- Clear notification for referees when there are scheduling changes made (Gotsoccer does not generate notification of game schedule changes)
- Should coaches, not league reps, be present at seeding mtgs.?
- How will errors/ corrections be handled with score reporting?
- Should we distribute a team satisfaction survey?
- What else needs attention?

Proposal (Rodney): a small committee will be formed to handle these issues.

Motion (Tino) Change the current guest rule to only allow guesting down. ?- 2nd. Motion defeated- current rule stands.

Motion (Bennett) Younger players playing "up" can guest down one division (ie. Gold to Silver). Jill- 2nd. Motion defeated.

Discussion about roster size for 8 v 8 age groups- 13 players is the current guideline. D2 can reevaluate the limit and possible changes next season.
